Who can join?

To join, you must be entitled to Medicare Part A, be enrolled in Medicare Part B, and live in an institution such as an Assisted Living Community, Assisted Living Home, Board and Care group home, the independent living section of a continued care Medicare community (CCRC), or within the long-term care/custodial nursing home.

Who can join?

To join, you must be entitled to Medicare Part A, and be enrolled in Medicare Part B.

Which doctors, hospitals and pharmacies can I use?

Our plans have a network of doctors, hospitals, pharmacies, and other providers. If you use the providers that are not in our network, the plan may not pay for these services.

You must generally use network pharmacies to fill your prescriptions for covered Part D drugs.

What are my drug costs?

Our plan groups each drug into "tiers." The amount you pay depends on the drug's tier and what stage of the benefit you have reached.
